



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	Ethanology Distillation is a distillery that earns a material amount of revenue from the sale of alcohol
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	In the previous fiscal year, 90% of Ethanology Distillation's revenue was earned from the sale of alcohol
IMPACT ON STAKEHOLDERS	Alcohol may have a negative impact on the health and well-being of individuals and their communities
IMPLEMENTED MGT PRACTICES	Ethanology Distillation declares to comply with all of the regulations and laws related to the sale of alcohol in the jurisdictions where it operates. The company reinforces that it is not allow any overconsumption of alcohol in their facilities, and that they are vigilant when evaluating each guest before serving and before any subsequent craft cocktails. Each mixologist is required to take the TIPS course (Responsible Alcohol Training & Certification) and pass the test to become certified. They also have in-house training to identify the characteristics associated with overconsumption and how to properly and effectively 'cut someone off' and how to mitigate tension when not serving. They also claim to have a formal ID policy that anyone under 40 is ID-ed. They also train their employees on how to identify a fake ID and have an ID book to further identify out of state fake IDs.
