- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

TOPIC	Arbitration with former distributor regarding termination of contract
SUMMARY OF ISSUE	In 2016, the company Davines North America Inc. received a formal claim from the distributor DePasquale Salon System, Inc. disputing the termination of the distribution contract operated, in the same year, by Davines North America Inc. In the same deed, the company DePasquale Salon System, Inc. requested the full payment of the contractually established amount for the "Market Equity Value" by challenging the just cause and by determining the contractual termination initiated by the counterparty.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	The aforementioned "Market Equity Value" was equivalent to \$1.1 million USD.
IMPACT ON STAKEHOLDER(S)	This arbitration relates to a financial impact on one of Davines North America's distributors due to the termination of their contract by Davines North America.
RESOLUTION	On 7 February 2017, the arbitration judge rejected the defense applications of Davines North America Inc. and required the company to pay the aforementioned amount relating to the "Market Equity Value" for \$1.1 million USD, by offsetting legal expenses incurred by the parties.
OTHER MANAGEMENT COMMENTS	Despite the negative outcome of this legal dispute and the findings highlighted in the arbitral proceedings, the company Davines North America Inc. still remains convinced of the correctness and consistency of the reasons given by the same and on the basis of the contractual termination with the former distributor
