Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Disclosure Questionnaire Category: Disclosure Industries

Topic	Clients in Controversial Industries
Summary of Issue	Canard & Cie produces video material and has had a client in the fossil fuel industry on an ongoing basis. The content of the videos produced for this client has included transmitting the purpose of the energy industry as well as a video highlighting a bird protection device around their client's wind turbines. The company's service could be sold to other customers in different non-controversial industries, the company has not designed a specific solution for the controversial industry customer.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	Clients operating in the fossil fuel industry represented 0.12% of the company's total revenue in 2022, 1.42% in 2021 and 0.7% in 2020.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry.
	B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Management Practices	Canard & Cie has drawn up an anti-dream list or blacklist of companies that are too opposed to its values and convictions for it to even consider working with them. It was drawn up taking into account the opinions and suggestions of each member of the team. Subsequently, the executive management finalized the following version:
	Extremist political parties, which often advocate violence and discrimination against certain communities.
	Religious organizations, which can sometimes encourage discriminatory or violent behaviour towards those who do not share their faith.
