Disclosure Questionnaire Statement

Disclosure Questionnaire Category: Industries at risk for human rights violations

Topic	Company sources metal precious and gemstones
Summary of Issue	Fay Page is a jewelry retailer and manufacturer whose products utilize precious metals. These raw materials could be considered conflict minerals and pose a potential human rights risk.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	Approximately 82% of the company's Cost of Goods Sold comes from raw materials that would be considered a high risk for human rights violations.
Impact on Stakeholders	The use of precious metals and gemstones poses a human rights risk due to the possibility that they are sourced from conflict-affected and high risk areas, where they may be used to finance conflict and/or be associated with human rights abuses in the supply chain.
Implemented Management Practices	Fay Page chooses its suppliers based on a "value match" screening; they screen suppliers both around "positive" (mission-driven local social enterprise) and "negative" (harmful or illegal practices such as bad working conditions) criteria. Fay Page is committed to purchasing from local suppliers (Cornwall) with diverse ownership (underrepresented populations) as much as possible to promote diversity in the supply chain (minimum 10% of company's non-labour expenses by 2030). Currently, local suppliers include packaging producers and website designers. Supplier screening criteria: - Compliance with all local laws and regulations, including those related to social and environmental performance. - Good governance, including policies related to ethics and corruption. - Positive practices beyond what is required by regulations (e.g., environmentally friendly manufacturing process, excellent labour practices). - Third-party certifications related to positive social and/or environmental performance. - Owned by underrepresented populations. - Based locally as much as possible.



Fay Page chooses precious metal suppliers based on their credible certifications and assurances related to the origin and traceability of the materials and products provided. The company only has two suppliers. One of them is Code of Practices Certified by RJC and Fairtrade Gold certified. The second one is Chain of Custody Certified by RJC.

Their suppliers also have codes of conduct applicable to their supply chain and conduct ethical audits to verify the practices on the ground. Fay Page also has a written code of ethics which includes the following statement:

"The company does not knowingly purchase materials (precious stones or metal) from conflict areas, and actively seeks out recycled materials as much as possible to reduce primary resource depletion."
