Disclosure Questionnaire Category: Operations located in Conflict Zones

Topic	Company has operation in Conflict Zones
Summary of Issue	The company offered its digital platform and digital training to a local NGO in Gaza, which is considered a conflict-affected region due to the ongoing conflict between Israel and Hamas. The majority of the company's operations (99%) are in Europe and other non-conflict countries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	0% of income came from the operation in Gaza during the last fiscal year, as the operation was temporary and fully funded by a Dutch government subsidy.
Impact on Stakeholder(s)	Business activities located in conflict zones are considered high-risk as they are more likely to cause or contribute to the conflict and/or sociopolitical instability.
	Countries classified as conflict zones are more likely to have a weak rule-of-law or a corrupt judicial system, which could undermine the effectiveness of operational grievance mechanisms for these businesses and their suppliers. In addition, the safety of the company's workers and other potential human rights violations are at risk.
Implemented Management Practices	The company does not have any people on the ground in Gaza and only supports community members digitally. The activity was funded by a Dutch government subsidy. The company's involvement is limited to digital support and has no ties to the conflict in any way.
