

DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

DISCLOSURE QUESTIONNAIRE CATEGORY	Product Recalls
ISSUE DATE	Mar-19
TOPIC	Company products were voluntarily recalled due to mislabelling
SUMMARY OF ISSUE	Two separate batches were recalled. The first was recalled as it was partly packaged with UK rather than US packaging, resulting in incorrect allergen information on the back of the packaging - pecans were listed when product contained almonds. The second was recalled as a product included a vegan label on back of pack when it contained milk ingredients.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	The first batch accounted for 5,310 mislabelled units and the second batch accounted for 17,856 mislabelled units. The recalls represented 0.07% of the company's total revenue.
IMPACT ON STAKEHOLDER(S)	Products mislabelled with allergens pose an allergy risk to customers. Graze has never received notice of any instances of consumer harm in connection to this mislabeling.
IMPLEMENTED MGT PRACTICES	In the case of the first recall, the company co-ordinated with the US FDA to recall the product. Retailers were immediately informed and processes were enacted to remove the stock and notify customers. For the second recall, the company co-ordinated with the UK FSA to recall the product. Stock was quickly recalled. As a result of both recalls, the company conducted a review of their practices in order to identify & address any issues. Graze's product labelling processes have undergone significant improvements, with additional resource and safeguards added. They now have a dedicated packaging and labelling advisor as a permanent member of the technical (food safety) team and have invested in workflow software to manage this process.
