Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Disclosure Questionnaire Category: Litigation

Issue Date	February 2016
Topic	Litigation related to: Contract dispute with independent contractor.
Summary of Issue	The company has had 1 litigation case considered material over the past 5 years. The litigation was related to the termination of a license agreement with an independent contractor. The ex-contractor, located in the Netherlands, alleged that the company was not permitted to terminate their contract based in the United States. Dmarcian considered that the ex-contractor was violating most of the contract terms. The company continues to reason that this case should be heard in the United States, where jurisdiction has been established as valid. This case went to court, where the company lost, but then proceeded to win the appeal. The ex-contractor has filed a new appeal with the Supreme Court of NL.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	The aggregate value that the claim represents in relation to the company's total revenue lies within the spectrum of 1% to 5%.
Impact on Stakeholders	Former external contractor was impacted.
Resolution	The appeal brought forward to the Supreme court by the ex-contractor will not reach a verdict for another 1-2 years.
Implemented Management Practices	All contracts with independent contractors have been terminated and they no longer contract externally - aimed at preventing similar issues in the future.
