Topic	Clients in Controversial Industries
Summary of Issue	Wove is a company that offers strategic marketing services to its clients and has had a one-off engagement with a client operating in the Gambling industry over the last 5 years. The work for this client involved a rebrand, including the creation of a new name, visual assets, logos and graphic definitions as well as website design recommendations. The work was never used by the client and the company no longer works for this company.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	Clients operating in the Gambling industry represented 6% of the company's revenue in 2019. Wove made a commitment in 2019 to no longer work with clients in the Gambling industry.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry.
	B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Management Practices	The company is committed to decline any future invitations to pitch or quote work for companies operating in the Gambling industry.
