Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Summary of Issue	E WASTE SOLUTIONS is a company dedicated to the integrated management of industrial waste with experience in environmental consulting that provides services to clients in controversial industries such as Whole life insurance products, Fossil Fuel (others excluded coal and oil sand), For-profit higher education and Animal Products or Services. Their services can also be sold to non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	For the fiscal year 2023, the revenue generated from clients in controversial industries accounted for approximately 11% of the company's overall revenue: - 2% of the client revenue has been from clients in the Whole life insurance products industry. - 6% of the client revenue has been from clients in the Fossil Fuel (others excluded coal and oil sand) industry. - 2% of the client revenue has been from clients in the For-profit higher education industry. - 1% of the client revenue has been from clients in the Animal Products or Services industry.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	The company does not consider these industries controversial. The company works with clients who do not compromise their code of ethics, and its services aim for good environmental practices.
