Disclosure Questionnaire Category: Other - Clients in Controversial Industries

Topic	Clients in Controversial Industries
Summary of Issue	Awebi provides website maintenance services and has served clients operating in the Offensive Weapons/Firearms Industry over the last 5 years. The client in this industry sold weapons to collectors and athletes, and specialized in antique weapons for enthusiasts and collectors. The company's services can be sold to both clients in controversial as well as non-controversial industries. The company no longer serves clients in this industry.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	Revenue from one client operating in the Offensive weapons/Firearms Industry represented 0.02% of Awebi's revenue each year between FY2019 and FY2023.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	In 2024, Awebi made a formal commitment to stop serving the client operating in the Offensive Weapons/Firearms Industry and no longer serve this industry. Prior to this commitment, the company refused to take on any projects related to development, production, use or promotion of controversial armaments (nuclear, biological, chemical weapons etc.) The company's due diligence process for evaluating new projects includes a thorough evaluation to ensure their projects do not conflict with their CSR charter and have specific email alerts and internal communication tools to raise ethical alerts. One day each year the company informs their team to ensure their concerns are put to practice.
