Topic	Litigation related to employees and employees of a contracting company
Summary of Issue	<p>LD Constuctora currently faces ;</p> <p>8 litigation cases that were resolved through payment related to employee unjustified dismissal and recovery of labor benefits, Claim for compensation for damages, Claim for compensation for damages due to occupational disease, payment of labor benefits, Economic unity claim, Claim for compensation for moral damages.</p> <ul style="list-style-type: none">• 1 pending litigation related to employees claiming for protection due to a violation of fundamental rights was rejected by the court and is currently before the Valparaiso Court of Appeals.• 3 Pending litigation cases involving company employees include allegations of: unjustified dismissal based on Article 161, paragraph 1 of the Labor Code; non-payment of prior social security contributions; violation of fundamental rights due to a workplace accident; and unjustified dismissal based on Article 159 No. 4, expiration of the fixed-term contract.• 15 litigation cases that were resolved through payment related to the employees of the company's contractors with claims of constructive dismissal for serious breach, work accidents, unfair dismissals, dismissal annulments, moral damages, recovery of employment benefits, subcontracting, labor benefits, violation of fundamental rights, and damages due to work-related accidents.• 3 pending litigation cases related to the employees of the company's contractors with claims of work accident, unjustifiably dismissed for abandoning work, and claims of verbal dismissal by the contrasting company, owing wages, prior notice, payment of contributions, and overtime.

Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	<p>The settlement amount for each litigation case was valued at less than 1% of the company's revenue in the last fiscal year. The estimated value for each pending case is expected to be less than 1% of the company's total revenue. The cost of all the cases is estimated to be valued at 1-5% of the company's total revenue in the last fiscal year.</p>
Resolution	<p>Litigation cases were resolved primarily through settlement in and out of court. Some cases are pending a final resolution through the court.</p>
Impact on Stakeholders	<p>The direct and indirect employees face potential negative impact financially and in terms of their welfare.</p>
Management Practices	<p>In addressing and mitigating similar occurrences, LD has strengthened its policies regarding the occupational health and safety of its workers throughout the development of its projects. Whenever an unavoidable accident occurs during the company's projects, regardless of its severity or whether it affected a local worker or a contractor, a thorough investigation is conducted to determine the root cause of the accident, determining what caused it and how it could have been avoided. This information is then disseminated to all of the company's projects with the goal of increasing care at the specific point of failure that may have caused the accident.</p> <p>LD works with the Serres platform to ensure compliance with the labor and social security obligations of all its contractors, ensuring that all workers providing services to LD receive their corresponding salaries in accordance with current regulations. Serres is a company accredited by the authority to certify compliance with labor and social security obligations, in accordance with Law No. 20,123. Its processes are validated by the National Standards Institute (INN), which has accredited it as a Type A Verification Entity, according to NCh-ISO 17020-2012.</p> <p>The company is also working on contractor control policies, management tools, and supplier/contractor monitoring.</p>
