Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

B Lab's Public Complaints Process

Any party may submit a complaint about a current B Corp through B Lab's Public Complaint Process. Grounds for complaint include:

- Intentional misrepresentation of practices, policies, and/or claimed outcomes during the company's certification process
- 2) Breaches of the B Corp Community's core values as expressed in our Declaration of Interdependence

Summary of Issue	LookAround Srl has clients in the following industry: Tobacco.
	The types of services offered to these clients include: strengthening clients' marketing strategies campaigns contents events
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In the last fiscal year, 5% of the company's annual revenue was from clients in the tobacco industry.
Impact on Stakeholders	Companies that work with clients in controversial industries can directly or indirectly increase the harmful impact on stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. Companies offering certain types of services and products to controversial clients are required to have at a minimum a grievance/complaints mechanism and a whistleblower protection policy.
Implemented Management Practices	LookAround Srl has the following mechanisms in place to manage the risks related to its business relationships with clients in the ineligible industry: tobacco.
	Grievance/complaints mechanism. This is accessible to the public through the company's website. The site would direct stakeholders to an online form where they can report any complaints/concerns. The company would accept any report surrounding Unfair Action / Violation of Rights, Harassment, and actions violating the company's Non-Discrimination Policy & General Complaint Policy for Staff / Administration and the company's operations.



	The company would provide a receipt of the complaint and confirmation of receipt within a maximum of 5 working days. Communication of resolution or actions taken will occur within 15 business days. If the complaint is not accepted, a clear and written reason will also be provided within 15 working days.
	 Whistleblower Protection Policy. The policy includes the following statements: The agency's board, including area directors, guarantees careful listening and serious and confidential treatment of every report received. Complaints can be made confidentially or anonymously, ensuring the identity of the whistleblower is protected. WLA ensures that there will be no retaliation against those who act in good faith to report misconduct The company provides access to a dedicated contact point to guarantee protection Consequences for Acts of Retaliation Any acts of retaliation against a Whistleblower will be considered a serious violation of the company's ethical principles and may lead to internal disciplinary actions/immediate termination of collaboration with the responsible parties (e.g., suppliers/clients, etc) torsion
