Summary of Issue	Analisis is a distributor and manufacturer of instruments and furniture for laboratories as well as providing a quality label to laboratories in the Benelux. The company has had clients operating in the Offensive Firearms and Weapons, Defense industries, Alcohol, Bottled Water, Fossil Fuels (coal, oil sands), Nuclear Power or Hazardous Materials and Pharmaceutical industries over the last 5 years. The company's service can be sold to both controversial as well as non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In FY2022 revenue from the client in the Offensive Firearms and Weapons industry represented 0.0097%. The company no longer works with this company nor this industry. From the company's FY2022 revenue: • Clients from Defense represented 0.0045% • Clients in the Alcohol industry represented 0.52% • Clients in the Bottled water Industry represented 0.02% • Clients in the Fossil Fuels (coal, oil sands) represented 0.18% • Clients in the Nuclear Power or Hazardous Materials industry represented 0.17%. • Clients in the Pharmaceutical industry represented 22%
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented	The company has stopped working with the client in the



Management Practices	Offensive Firearms and Weapons industry and has committed by the Board of Directors to not work with any other companies in this industry. Clients in Defense is a military hospital that cares in a majority for civilians. The company does not currently have a position on working with clients in controversial industries and does not have policies or practices in place to ensure that their services are not used by their clients to cause harm.
