### **Disclosure Materials**

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

#### **B Lab's Public Complaints Process**

Any party may submit a complaint about a current B Corp through B Lab's Public Complaint Process. Grounds for complaint include:

- Intentional misrepresentation of practices, policies, and/or claimed outcomes during the company's certification process
- Breaches of the B Corp Community's core values as expressed in our Declaration of Interdependence

Topic	Clients in Controversial Industries
Summary of Issue	The company has been serving clients in the alcohol industry by offering design and packaging services on an ongoing basis over the last 5 years. Their services can also be sold to non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	3.08% of revenue in 2023 comes from the alcohol industry.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry.
	B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	Alca does not have screening policies for clients and does not require their clients to sign any code of conduct. The company also does not have any positions on working with clients in controversial industries.
