



## DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

<b>DISCLOSURE QUESTIONNAIRE CATEGORY</b>	Operations in conflict zones
<b>TOPIC</b>	Company provides advisory services to humanitarian organizations in regions affected by conflict.
<b>SUMMARY OF ISSUE</b>	Humanitarian Advisory Services sometimes provides services to humanitarian organizations operating in regions affected by conflicts. The company conducts research and works with its client organizations to influence donors and improve how humanitarian assistance and protection is delivered.
<b>SIZE/SCOPE OF ISSUE</b> (e.g. \$ financial implication, # of individuals affected)	Approximately 13% of the company's revenue from the previous fiscal year came from projects for organizations operating in conflict-affected areas.
<b>IMPACT ON STAKEHOLDERS</b>	Conflict zones are often characterized by widespread human rights abuses and violations of national or international law ( <a href="#">OECD</a> ) and thus operations tied to such areas require sufficient management practices to mitigate the risk of potential harm.
<b>IMPLEMENTED MGT PRACTICES</b>	<p>Humanitarian Advisory Services utilizes guidance from the <a href="#">International Committee of the Red Cross</a> to identify projects related to operations in conflict zones.
