Issue Date	Ongoing
Topic	Energy and Emissions Intensive Industries
Summary of Issue	Sheard Packaging manufactures corrugated cartons and packaging materials. They use energy (electricity) to convert cardboard into boxes and produce emissions as a result of these processes. The main contributor to the company's energy and emissions intensity is the transformation of raw material into a product.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	100% of the revenue comes from energy-intensive product manufacturing. Their main energy sources used by the company are Electricity, Bio diesel, Diesel, Solar Power, Fuel Oil (Kerosene). The company's carbon intensity was 29.40 metric tonnes of CO2 / \$ million of revenue
Impact on Stakeholders	Sheard Packaging is involved in the production/sale of products, and is part of an industry that could be classified as energy and emission-intensive, meaning that they are more likely to have significant impacts on the environment based on their carbon emissions associated with their operations and their contribution to climate change.
Implemented Management Practices	Sheard Packaging have installed solar panels to reduce the use of non-renewable energy sources. The company fixed electricity contract expires in 2026, they aim to transition to procuring fully renewable electricity by 2027. The company commit to reduce scope 1 and scope 2 GHG emissions 42% by 2030 from a 2022 base year, and to measure and reduce its scope 3 emissions The manufacturing processes is based on 'lean manufacturing' principles. The company have procedures in place to 'turn-off' machinery, Forklift Trucks (FLT's), so they reduce 'idling' machinery & vehicles to conserve energy.

	In some areas, the company have removed FLT usage and replaced with automatic conveyors– less energy intense than diesel powered FLT. Installed low-energy motion sensored LED lighting, removed all conventional lighting and have installed new equipment that is more energy efficient – and decommissioned older machinery which is less energy efficient.
