Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Topic	Litigation related to Labor and Contract Dispute
Summary of Issue	The company is involved in one legal proceeding related to an employment termination and in two contractual matters associated with a campus development project. These matters are being addressed with diligence, transparency, and full respect for the applicable legal processes.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	As of 2025, the company is involved in several ongoing legal matters related to both labor and contract disputes, with a total combined litigation representing 1–5% of annual revenue.
Impact on Stakeholders	The potential impacts related to contract dispute litigation is financial impact on the company, employees, and contractors (third party).
Resolution	The cases are pending final resolution.
Management Practices	<p>At this stage, no new practices or policies have been formally introduced.</p> <p>However, the company is currently reviewing its existing frameworks to identify potential gaps and determine whether updates or new measures are needed.</p>
Management Comments	The cases related to the contract dispute with contractors are one-offs and are usual in construction works of this size; there are no additional actions to be taken by the company other than settling the cases.

Summary of Issue	<p>B Lab recognizes that for-profit higher education is controversial and that a number of industry participants have questionable reputations. B Lab sees its role as the promotion of robust standards of industry-specific performance, expanded legal accountability, and public transparency that can be used by policymakers, investors, and the general public to make more informed decisions about which for profit high education institutions meet market demand while generating the greatest positive impact and best serving the public interest. We have created a specific set of standards to address issues unique to for-profit higher education companies:</p> <p>The Higher Education Addendum of the B Impact Assessment is the result of nearly 2 years of work with a distinguished group of industry experts and includes industry-specific metrics on:</p> <ol style="list-style-type: none">1) Educational Models and Engagement: The extent to which the company is able to deliver long-term, sustained educational services and its engagement with the higher education and broader community to advance higher education and promote wellbeing2) Recruiting, Marketing, and Transparency: The policies, practices, and results of the institution’s recruiting practices to ensure accurate information and consumer protection3) Student Outcomes: The extent to which the institution delivers positive outcomes for its enrollees, particularly for traditionally underrepresented groups, including their ability to progress to completion and achieve economic independence4) Student Experience: The extent to which the institution delivers a positive student experience, including quality instruction and faculty, supportive and accessible student services, and external career and service opportunities
