Topic	Company's remote workers are located in Conflict Zones
Summary of Issue	Jellyfish Pictures Ltd is a UK-based animation and VFX studio that employs remote workers in Israel, Ukraine, and Turkey. According to the Global Conflict Tracker, Israel , Ukraine and Turkey are considered conflict zones. The company does not have any clients, suppliers, or operations in these regions; their remote workers are freelancers.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	The employees working in conflict zones account for 0.94% of the company's total workforce.
Impact on Stakeholders	Business activities located in conflict zones are considered high-risk as they are more likely to cause or contribute to the conflict and/or sociopolitical instability. Countries classified as conflict zones are more likely to have a weak rule-of-law or a corrupt judicial system, which could undermine the effectiveness of operational grievance mechanisms for these businesses and their suppliers. In addition, the safety of the company's workers and other potential human rights violations are at risk.
Implemented Management Practices	The company has an anti-discrimination policy, an anti-bribery and anti-corruption policy, a modern slavery statement, a code of ethics, and an occupational health, safety, and wellbeing policy in place.

This commitment means that we employ talented individuals remotely, including in countries classified as conflict zones.
