Topic	Pesticides and fertilizers industry
Summary of Issue	Brascorp is an Argentinian company focused on animal nutrition. One of its products, Braciper® , is an insecticide composed of Piperonyl Butoxide / Cypermethrin that is used for pest control in facilities where animals live.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In the last fiscal year, the Braciper's sales represented approximately 0.1% of Brascorp's total revenue.
Impact on Stakeholder(s)	Fertilisers can have an impact on biodiversity, water sources and affect air quality and human health.
Implemented Management Practices	Braciper has the corresponding authorizations from the competent local authorities (Servicio Nacional de Sanidad y Calidad Agroalimentaria), and abides by the local regulations applicable to insecticidal products for environmental use in the animal nutrition industry. The marketing materials include technical information and safe use instructions to minimize risks. It promotes proper application and handling of its products, ensuring compliance with current regulations and technical recommendations for safe use. Packaging management is carried out in accordance with applicable local regulations, and the proper use and correct disposal of containers is promoted in line with the corresponding recommendations for this type of product. Brascorp SA is developing a biopesticide as an alternative product to replace Braciper®, with the aim of controlling pests in livestock facilities using microorganisms that have already been proven not to be hazardous to public health or the environment.
