



## DISCLOSURE MATERIALS

- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

<b>DISCLOSURE QUESTIONNAIRE CATEGORY</b>	Facilities located in sensitive ecosystems
<b>TOPIC</b>	Company has a factory located in a sensitive ecosystem - Disposal of effluents from industrial activity
<b>SUMMARY OF ISSUE</b>	The factory is located in the watershed of the Arienga river (in an Amazon Biome which is classified as a protected ecosystem by government agencies), approximately 600m from the water body and its permanent protection area. The river will receive part of the treated wastewater from the factory.
<b>SIZE/SCOPE OF ISSUE</b> (e.g. \$ financial implication, # of individuals affected)	50% of the company's production, in terms of volume, occurs in the facilities located in a sensitive ecosystem. The average effluent flow is 39m <sup>3</sup> /day and the maximum is 82 m <sup>3</sup> /day.
<b>IMPACT ON STAKEHOLDERS</b>	Although the factory does not work with toxic chemicals, failure to treat wastewater can increase the amount of nutrients in the water, altering its physicochemical properties. For this impact, the terrestrial and aquatic ecosystems of the Arienga River watershed and the population residing there are considered.
<b>IMPLEMENTED MGT PRACTICES</b>	<p>In the watercourse, 3 points of semiannual analysis were established to monitor the water quality of the Arienga River. The effectiveness of the treatment is checked at the station and a more complete end-of-tube analysis is done every 3 months. The project of the effluent treatment plant has been approved by the competent body and guarantees an efficiency above that required by environmental legislation.</p> <p>The company is ISO-9001:2015 certified which guarantees the quality of its processes. In addition, their permanent staff includes 2 environmental engineering technicians and 3 chemical engineers among other professions with the intent to control the internal environmental management system.</p>
