



DISCLOSURE MATERIALS

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

ISSUE DATE	October 2018
TOPIC	Significant layoffs after the closing of a factory in Ethiopia
SUMMARY OF ISSUE	Employees were terminated at the end of a large project. The employees had been hired for the duration of that project on a full time contract without an expected end. It was the first time that a project of this magnitude has been undertaken by the company and the employees were advised verbally during the hiring process that they would only be employed for the duration of the project.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	111 employees were laid off, representing approximately 95% of the company's employees at that time.
IMPACT ON STAKEHOLDER(S)	<p>Following the laws in Ethiopia and property severance, company provided all staff severance pay, in addition to distributing their Fair Trade premiums which normally happen at the end of the year. In addition, company in Ethiopia informed other shoe factories in the area about the upcoming layoffs in order to transition staff wherever possible. The management does not know whether the employees that were laid off were able to obtain subsequent employment.</p> <p>As this was a unique case, and given company was a fair trade certified factory in Ethiopia, they spent considerably extra time and financial resources to provide additional time before the official layoff, but also included the workers in the ongoing discussion on how the process would unfold. While not ideal, there was constant communication and interaction with employees throughout the process.</p>
IMPLEMENTED MGT PRACTICES	The company has not created any formal policy to date that deals with the hiring of full time staff for the duration of large projects.
