Disclosure Materials

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to a background check by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Topic	Clients in Controversial Industries
Summary of Issue	Próxima is a marketing and public relations company that has served a client operating in the Alcohol industry on an ongoing basis over the last 5 years. Services to this client have included corporate communications services focused on sustainability; specifically in managing relations with media and interest groups and publicizing the company's commitment to mitigating their footprint. The company's service is not involved in the promotion or sale of alcoholic products. Próxima's services can be sold to both companies in controversial as well as non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	Revenue from the client operating in the Alcohol industry in FY2023 represented 10.18%.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	Próxima has a manifesto in their Internal Policy Manual in which they state that they will not work with the following industries: • Tobacco • Gambling • Mining • Pornography • Offensive Firearms/Weapons • Fossil Fuels - extraction, distribution and/or sale of fossil fuels such as petroleum, carbon or gas. • Industries that depend on the use of materials that have a high chance of causing human rights violations

	● Politics ● Other industries that could cause social or environmental damage; that are subject to criticism from stakeholders and that are a motive of concern for those stakeholders and that do not demonstrate a genuine commitment with the reduction of impact. The company's process to evaluate potential new clients or projects involves having a meeting with clients to understand implications of the project, the interest groups and the possible consequences/impact that can be generated from their intervention. If these are not compatible with Próxima's ethics or beliefs, the project is rejected.
