



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

ISSUE DATE	April 13, 2023
TOPIC	Legal dispute with client over construction of home.
SUMMARY OF ISSUE	Case: The company constructed a home for a client who expressed dissatisfaction with certain aspects of the house. Part of the deficient work surfaced after the completion of the project, which was attributed to a subcontractor. The subcontractor agreed to pay a portion of the final settlement. The matter has since been resolved and settled.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	The case has been settled with a payout amounting \$112,000 , which represents 2.11% of the company's revenue.
IMPACT ON STAKEHOLDERS	The dispute between the contractor and client over alleged defective work can significantly impact various stakeholders involved in the project, potentially leading to financial losses, damaged relationships, and adverse reputational effects.
RESOLUTION	The case was settled and the litigation processes have been closed.
IMPLEMENTED MGT PRACTICES	In order to address the situation, the company has opted to implement stricter job site security measures and enhance its processes for dealing with defective subcontractors. To improve job site security, the company is enforcing a policy where sites are locked down during shut down periods, and clients are not allowed access unless a site manager is present. In addition, the company is withholding the final payment of subcontractors until all defects have been rectified. The company is also committed to providing regular program and budget updates to clients who wish to be kept informed of the construction process. To streamline the process and improve subcontractor and client relationships, the company has employed contracts administrators to take ownership of these relationships.
