



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

| SUMMARY OF ISSUE | <p>Marvel FMCG Ltd is a company that regularly provides recruitment services for sales and marketing roles to clients in the FMCG Industry including alcohol and non-alcohol companies.</p> <p>The services that they provide do not directly influence how these companies manage their practices and comply with legislation.</p> |
| SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected) | <p>46% of the client revenue has been from clients in the alcohol industry.</p> <p>Their fee structures are negotiated on an individual company basis depending on a number of factors such as number of roles, length of contract term, exclusive or non-exclusive basis.</p> |
| IMPACT ON STAKEHOLDERS | Companies that offer products/services to clients in controversial industries may be contributing to the controversial impact of those industries. |
| IMPLEMENTED MGT PRACTICES | <p>The company only works with clients that operate in the FMCG industry. The company does not yet have a formal process in place for carrying out due diligence of clients that they work with on the potentially harmful impacts of the clients. They currently discuss the onboarding of any new clients as a team.</p> <p>They do not have a prohibitive list of companies that they will not work with but have declined to work with companies where they have observed practices that don't align with their culture and values. They have set ESG targets that operate across the companies that they work with based on charitable donations, carbon neutrality and governance based on B Corp principles. They will consider implementing a more formal due diligence process in the future.</p> |
