Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	Volunteering is part of the company's corporate social responsibility efforts, which involve organizing summer camps for Save the Children Denmark. The summer camp takes place on the company's premises and has been organized yearly since 2018. Dalllund Slot supports Save the Children Denmark, an NGO and a member of the world's largest independent children's rights organization, Save the Children International. Save the Children is the largest children's rights organization that fights violence, abuse and bullying, and builds safe communities for children and families in vulnerable positions. Save the Children Denmark has more than 2,000 volunteers who are organized in 60 local associations throughout the country. The volunteers provide experiences for children at holiday camps, in nature and in local communities.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	The company is committed to performing at least one corporate social volunteer action per year. Generally, Dallund Slot hosts 15 to 20 children during the camp, for which more than 10 Dallund Slot volunteers participate in different activities such as preparing meals, cleaning, and working with the children. Save the Children have 15 volunteers arranging the summer camp, which usually starts in April or May. Then the camp is held the first week of July.
IMPACT ON STAKEHOLDERS	Volunteer programs involving children, if not managed appropriately, could potentially pose risks to children, such as disruption of development due to short term connections with caregivers, as well as, risks to children's safety and well-being.

IMPLEMENTED MGT PRACTICES	Dallund Slot employees and volunteers are screened and a background check is carried out by Save the Children Denmark. Dallund Slot employees and volunteers who make the preparations for the camp and help with cleaning up after the camp do not need special approvals or training as they do not work or engage with the children. Dallund Slot employees and volunteers who attend the camp have to get a "Børneattest" which is a document confirming that volunteers are allowed to work with children, which is then confirmed by the police.  The company has a Child Safeguard Policy. Its main components include a Child Protection
	Philosophy, the requirement to safeguard all children, a commitment that applies to all staff consistently, the identification and management of risks, and the integration of safeguarding measures throughout the organization.
