Disclosure Questionnaire Statement

Disclosure Questionnaire Category: Industries at Risk of Human Rights Violations

Topic	Company sells jewelry with precious metals and laboratory diamonds
Summary of Issue	Gaen is a jewelry retailer that uses precious metals, which could be considered conflict minerals and pose a potential risk to human rights in the raw material supply chain.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	Within the supplier's expenses, 46% of the spending on raw materials corresponds to recycled gold and 54% to laboratory diamonds. All of the recycled gold used in their products is traceable by blockchain or has an FCS (Fair Chain Supply) certificate and all of the diamonds used are synthetic and produced in a laboratory.
Impact on Stakeholders	The use of precious metals poses a human rights risk due to the possibility that they are sourced from conflict-affected and high-risk areas, where they may be used to finance conflict and/or be associated with human rights abuses in the supply chain.
Implemented Management Practices	The company has policies and practices in place to ensure that it sources from suppliers who are committed to respecting the environment and avoiding illegal practices like child labour. To achieve this, the company has a code of ethics, anti corruption policy, supplier relationship policy, and approval process, which includes supplier's facility visits and adherence to Gaen's principles. The company has implemented blockchain tracking for the majority of its recycled gold. The recycled gold also holds an FCS certificate, which allows for tracking its origin. Furthermore, laboratory diamonds with at least 0.5ct are engraved with an identification number that includes the diamond's properties and origin.
