



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

DISCLOSURE QUESTIONNAIRE CATEGORY	Other - Clients in Controversial Industries
TOPIC	The company works with clients in the tobacco and fossil fuel industry on an ongoing basis. Proyecto Agua Segura also developed 2 projects in the last 2 years with a company in the pharmaceutical industry.
SUMMARY OF ISSUE	Proyecto Agua Segura develops, manages, and implements access to water, sanitation, hygiene, and water environmental projects that generate a positive impact on the business, on the efficiency of the resource, and on the communities. For the tobacco client, the company protects water springs for the company's producers. The objective of the service is to ensure quality access to the water source for consumption for the tobacco producers and their families. As for the fossil fuel company, the service is focused on the client's CSR strategy and its relationship with the community, through access to safe water. For the client in the pharmaceutical industry, the company focused on projects for access to water, sanitation and hygiene, through infrastructure and technology.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	30% of the company's revenues came from clients in the tobacco industry, about 3% from the fossil fuel industry, and 3% from the pharmaceutical industry.
IMPACT ON STAKEHOLDERS	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
IMPLEMENTED MGT PRACTICES	Agua Segura always works on sustainability and improvement projects in access to water, so it works with all industries focused on positively influencing the community, the environment and employees.
