Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Summary of Issue	The company is a web platform that has had clients in the Fossil Fuels and Pharmaceuticals industry. The nature of the company's services is to provide a commercial solution through a web platform (B2B), based on Artificial Intelligence, for quotations and tenders that was created to digitise the procurement processes of large companies, all services can be sold to both controversial as well as non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	The revenue from clients in the Fossil Fuels industry represented 0.01% in FY22-23. The revenue from clients in the Pharmaceuticals industry represented 0.13% in FY22-23.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	The company has a protocol of good practices, Confidentiality and Free Competition that is oriented to disseminate and fulfill the commitment that wherEX maintains, to respect the highest ethical standards in its commercial actions and promote such conduct among Employees and Users (Customers). Wherex's customers must read and sign the Service Agreement, which includes the Use of the Platform and Confidentiality, Data Protection, Communication, among other clauses. In addition, they must comply with the Protocol of Good Practices.
