

DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

ISSUE DATE	March 2020
TOPIC	Significant layoffs due to COVID-19
SUMMARY OF ISSUE	In March of 2020, United by Blue had the first round of layoffs in company history due to the effects of the COVID-19 pandemic.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	12 employees were laid off, representing 25% of the company's employees at that time.
IMPACT ON STAKEHOLDERS	Primary impact was loss of employment for affected employees.
IMPLEMENTED MGT PRACTICES	United by Blue has since rehired 5 of these employees. All managers were required to reach out to the laid off employees following the end of their employment to offer assistance finding new opportunities, including letters of recommendations, network connections, etc. Some employees were also offered temporary roles to stay on within if they were interested.
OTHER MANAGEMENT COMMENTS	Significant efforts were made to support employees in their subsequent job hunts, as well as to rehire laid off employees as soon as their department's were able.
