Animal Products and Services and Biodiversity Impacts
CONSERVAS ANTONIO PÉREZ LAFUENTE, S.A. sources produce directly from fisheries and aquaculture farms
The company sources from fisheries and aquaculture farms in >50% of their supplier expenses
100% of the company's revenues come from the sale of canned seafood derived from fisheries and aquaculture farms.
The company operates in an industry that is at high risk of overfishing and subsequent loss of fish stocks (biodiversity loss) when fishing is not conducted sustainably, which is a material environmental issue.
The company indicate that all products and raw materials are traceable. The company have a chain of custody traceability Certification BCS ÖKO Garantie, which certifies the processing with organic ingredients and the traceability of fishing according to European Community standards. Suppliers are verified annually. Suppliers of ingredients are required to be from organic agriculture and fishing and see food products suppliers are required their traceability; including origin information: specie, catch area-FAO, fishing gear, certification (if applicable), name/boat's flag, date of tide and discharge, port of discharge.
The company is certified under the Marine Stewardship Council Default standard, for Chain of Custody certified, Traceability of Friend of the Sea products, sustainable fish feed, fishmeal, fish oil and omega 3, FOS-Aqua, FOS-Wild, FOS-FF, FOS-FM, FOS-FO, FOS-O3 and CoC General requirements certified, Denominazione di Origine: Mussels from Ría de Arousa certified, seal of identity and quality for the promotion and defence of fish and seafood from the Galician artisanal fleet certified.
All fishes come from locally controlled fishing grounds with traditional non-predatory arts, respecting minimum sizes, protected species, fishing seasons and catch quotas are respected.
Traditional fishing methods such as hook and small purse seiner are used by the company. These are less harmful than trawls, as they reduce pressure on fish populations and minimise the discarding of fauna that are of no commercial interest less harmful than trawls.

Supply chain traceability in the seafood industry is challenging, which contributes to the continued prevalence of these issues globally.
IMPLEMENTED MGT PRACTICES	The company confirms that 100% of the company's products can be traced back to the original source.
	All of their suppliers must fill out an approval questionnaire and present certificates or records to be updated annually: quality and/or organic certification, health registration, technical data sheets, analytical data, etc.  Concerning their suppliers from organics ingredients (oils, vinegar, vegetables, etc.), organic certificate is mandatory which confirm that the product comes from the ORGANIC AND/OR BIODYNAMIC AGRICULTURE without any chemical processing.
	Related to the seafood suppliers, Catch Certificate is mandatory for each purchase where, not only all the information from the fish traceability is included in it, but also name/flag of the boat and normally responsible person - Captain in case any social violation.
	They only work with authorized suppliers that operate under the legislation related to human rights. In case of any violation concerning human rights, they will be forced to break the business collaboration.
	They only work with fish and seafood suppliers who are officially registered and therefore regulated under the laws concerning labour procedures and rights of the country.
	They do not have the capacity to monitor their suppliers in relation to this issue however, as they indicated previously, they only work with legally authorized and registered companies and therefore, they must comply with all the required labor measures.
