



DISCLOSURE MATERIALS

SUMMARY OF ISSUE	<p>Cumulus Studio is an Architectural Design & Planning company that has had one client from the Hotel industry which is also involved in the Gambling industry (Hotel casino) and clients operating in the Alcohol industry on an ongoing basis. The nature of work carried out for the Hotel Casino was in relation a roof detailing issue. The services provided to clients operating in the alcohol industry were in relation to the design of bespoke Distilleries, Brewery and Winery Cellar Door. The company's services to clients in both industries do not directly enable harmful aspects of the industry but they do enable the growth of the industry. The service provided is adapted to the needs of the client, whereby the skillset and experience of each team member required for a particular project determine the standard hourly rates that will be charged. Clients in controversial industries and non-controversial industries have access to the same type of service and fee structure.</p>
