Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Issue Date	March 2021, April 2021 and January 2023
Topic	Customer Protection
Summary of Issue	In the last 5 years, the company has been involved in 3 litigation cases related to clinical negligence and injury caused to a customer.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	The total financial value associated with these 3 cases represents less than 0.5% of the company's annual revenue.
Impact on Stakeholders	Three patients and their families were physically and emotionally impacted by the incidents.
Resolution	Two cases related to clinical negligence are pending resolution. One case was closed with a denial of liability. There was a challenge to this denial in early 2022, however this was not successful and the file was closed without any payments
Implemented Management Practices	Following these incidents, Millennium Care purchased all the homes within the Group airway-clearing devices. The devices have proved effective through clinical studies. As well as this, the frequency of refresher training has been increased within all the homes. This includes first aid and choking training to ensure incidents are handled effectively and efficiently. This is now every 12 months for all staff as well as within the induction period.



Disclosure Questionnaire Statement

Disclosure Questionnaire Category: Facilities located in sensitive ecosystems
