Issue Date	Ongoing
Topic	MAGI Balkans is a polydiagnostic laboratory that generates medical waste considered dangerous.
Summary of Issue	MAGI Balkans polydiagnostic laboratory operates in Albania and offers services to clients in relation to testing, prevention and healthcare. The type of waste that is generated is special medical waste (e.g. blood tubes, medical gauzes, infectious materials, etc). The company does not generate or process radioactive material.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	100% of the company's revenue is derived from laboratory services. Approximately 85% of the company's revenue is related to activities that generate hazardous waste. The amount of hazardous waste handled by the company is about 15 kg every month. Since Magi Balkans is an analysis laboratory, the other types of waste are only domestic waste, representing a total of approximately 100kg every month. The % of hazardous waste handled by the company compared to the total amount of waste is 15%.
Impact on Stakeholder(s)	Hazardous waste, due to its physical-chemical and infectious properties, may pose a risk to public health and the environment.
Implemented Management Practices	MAGI Balkans places the medical waste in dedicated and safe containers and every 10 days a certified disposal company collects them and proceeds to the sterilization and incineration process. The hazardous waste management and disposal is done in compliance with the following laws and procedures: - Albanian Law no. 9537 of 18.5.2006 "On the management of hazardous waste". - Albanian Law no. 10431, of 09.06.2011 "On environmental protection", amended by Law 31/2013, of 14.2.2013, and no. 53/2020, 30.4.2020. - Albanian Law no. 8094 of 21.3.1996 "On the disposal of public waste". - Albanian Law no. 9115 of 24.7.2003 "On the environmental
