Disclosure Questionnaire Category: Animal Testing

Topic	The company voluntarily tests on animals
Summary of Issue	Withheart meat shop is a meat products wholesaler/retailer based in Taiwan. Yssa GOODTHINGS Co, included in the scope of Certification of Withheart meat shop and with whom they have shared owners, is involved in the manufacture and sale of pet food products. The company has conducted one animal trial during one of their product development processes, animal probiotic product NT 7500. Animal testing was conducted on pets, with the permission of pet owners; the product was offered to the animals by their owners. Testing intended to evaluate the palatability of new products. Health effect claims of products are supported by the conduction of non-animal use testing methods in a laboratory. The company did not track the results of the trial and did not pay the owners any compensation.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	The product involved in animal testing in 2022 represented a total of 0.084% of FY2022 revenue and less than 0.01% of the company's FY2023 revenue.
Impact on Stakeholders	Animal testing and experimentation is widely used to develop and test the safety of new healthcare and/or food products. Many of these experiments can cause pain to the animals involved or reduce their quality of life in other ways.
Implemented Management Practices	Withheart meat shop has a Animal Welfare policy published on their website (link below) establishing the company's commitments in relation to the sourcing of meat from legal farms with humane verification by third party, free range. In addition the company states that the animal experiments they conduct are mainly to sample new pet food products, clarifying that food samples are provided to clients and their pets in order to test the palatability and preference of the new product and that the company does not carry out invasive tests on animals.
