Topic	Manufacturing and selling of bottled water
Summary of Issue	Shropshire Trading provides solutions for problem stock, particularly in the food and beverage industry; managing excess or short dated inventory. The company derives part of its revenue from the sale of bottled water that is near or past their best- before date. Shropshire Trading is not involved in the extraction of water or manufacturing of bottled water. Their service diverts plastic bottled water from potentially going to landfill.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	Revenue from the sale of bottled water represented 0.22% of the company's FY2023 revenue.
Impact on Stakeholders	B Lab recognizes production and sales of bottled water as a material business issue and has a Framework for Evaluating Bottled Water Companies for B Corp Certification. As the company does not reach the 1% revenue threshold for the sale of its own brand bottled water, B Lab's specific Bottled Water Industry Certification Requirements do not apply at this time.
