Disclosure Questionnaire Category: Other - Clients in Controversial Industries

Topic	Clients in Controversial Industries
Summary of Issue	Asgreen Ingeniería Sustentable is an environmental engineering consultancy that has had clients operating in the Alcohol, Bottled Water, Mining, Pharmaceutical and Tobacco industries over the past 5 years. Services to these clients have included implementation of energy management systems as well as the quantification and verification of carbon and water footprints; all services that can be offered to both clients in controversial as well as non-controversial industries.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In FY2023 the company had the following % of revenue from clients in controversial industries: -0% from clients operating in the Alcohol industry. Revenue from clients in this industry over the last 5 years represented an average of 2%. -0% from clients operating in the Bottled Water Industry. The company no longer works with clients in this industry. Engagement with this industry was a one-off engagement in 2022. -25% from clients operating in the Mining industry. -1% clients operating in the Pharmaceutical industry. -0% from clients in the Tobacco industry. Engagement with this industry was through a one-off engagement in 2022 representing 0.50% of revenue at the time, the company no longer works with this industry.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	Asgreen has made a decision to stop working with clients operating in the Bottled Water and Tobacco industries as a result of being misaligned with the company's values. The

	company claims that they seek to provide sustainable value to the organizations they work with and help leave a positive footprint on society. Asgreen has in place practices and performance evaluations to ensure that their services do not have a negative impact on people or the environment.
Management Comments	The company also reported serving the timber industry by providing Energy Management System implementation services, quantification and verification of carbon and water footprints. Revenue from clients in this industry represented 0% of the company's FY2023 revenue and on average 0.028% of the company's revenue over the last 5 years. Asgreen no longer works for clients in this industry. This industry is not currently flagged by B Lab as a client in a controversial industry, but since the company recognizes the potential risks of working with this industry they have decided to self- report it.
