- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	Due to the financial impact of COVID-19 on Dopper's revenue, the company had to make the tough decision to end contracts with 16 of its staff.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	16 employees were laid off, representing ~26% of the company's employees at that time.

Dopper spoke to a lot of other companies to see if they had vacancies for people and gave the affected employees the opportunity to talk to its recruiter in order to assist them to create a good resume and LinkedIn profile. Two people got a job within Dopper's parent company. In addition, the company helped employees with all things related to unemployment benefits from UWV and had a lot of talks to help people cope with the difficult decision to lay off employees.
