Disclosure Materials

Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Summary of Issue	<p>Longchamp had litigations filed against them by former employees alleging the following labor issues: terminations, and a discrimination case, with no criminal case opened.</p> <p>Longchamp Manufacture France/HQ was sued due to allegations filed by former employees disputing their terminations.</p> <p>Longchamp North America Retail was sued due to allegations filed by former employees related to disputing their terminations, and a discrimination case, with no criminal case opened.</p> <p>Longchamp Europe Retail was sued due to allegations filed by former employees related to disputing their terminations.</p>
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	<p>Longchamp Manufacture France/HQ</p> <ul style="list-style-type: none">As of January 2026, Longchamp Manufacture France/HQ has 8 closed labor litigation cases. The total financial value of all these lawsuits represents less than 1% of the company's total revenue. <p>Longchamp Europe Retail</p> <ul style="list-style-type: none">As of January 2026, Longchamp Europe Retail has 24 closed labor litigation cases. Management Practices	<p>Longchamp is on a continuous improvement path. Global policies have been set up to prevent future cases:</p> <ol style="list-style-type: none">1. Investment in its HR department to improve processes (contract termination procedures), better define expectations through annual reviews and JDs, and improve working conditions overall.2. Investment in its manager community to share best practices, set expectations, and prevent professional burnouts, harrassments or discriminations. <p>In addition, specific practices have been updated locally, and yearly discrimination trainings on an ongoing basis have been set up in North America.</p>

Longchamp APAC Developed Markets has 7 employees under a Zero-Hour Contract, which allows the employer to vary the working hours of an employee, with no guarantee of employee hours, while the employee is required to be on call.
