



## DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

<b>TOPIC</b>	Company sells alcohol products
<b>SUMMARY OF ISSUE</b>	Treefort Music Fest is a five-day event that includes a material amount of revenue from the sale of alcohol. Alcohol is sold but not produced.
<b>SIZE/SCOPE OF ISSUE</b> (e.g. \$ financial implication, # of individuals affected)	In the previous fiscal year, no revenue was earned from the sale of alcohol. However in a typical year, about 20% of revenue is from alcohol sales.
<b>IMPACT ON STAKEHOLDERS</b>	Alcohol may have a negative impact on the health and well-being of individuals and their communities.
<b>IMPLEMENTED MGT PRACTICES</b>	<p>"The company complies with all regulations and laws related to the sale of alcohol in the jurisdictions where it operates.</p> <p>The company stated that it subcontracts alcohol service out to professional servers and individuals who have current TIPS certification. All staff are trained not to overserve visibly intoxicated individuals and it closes its bars relatively early (8pm/9pm most days) so as to avoid overserving attendees.</p> <p>The company sells a separate pass to Under 21 attendees so that they are visibly different from those who can consume. It also uses professional security to ID check and indicates that it doesn't have any staff or volunteers validate ID."</p>
