Issue Date	10/13/2022 - ongoing
Topic	Class action complaint regarding Danone Waters of Americas (DWA) carbon neutral claims
Summary of Issue	Evian Natural Spring Water bottled water, manufactured and sold by Danone Waters of Americas were marketed as "carbon neutral". However, some consumers claim that the carbon-neutral attributes stated on the product's label and packaging were false and misleading. The plaintiffs state that they would not have bought the products if there was not this indication of "carbon neutral".
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	Plaintiff seeks damages in excess of US\$5,000,000.
Impact on Stakeholder(s)	Primary impact was financial impact for affected consumers.
Resolution	The case is currently pending.
Implemented Management Practices	The following is the Company's public statement issued in response to this lawsuit, which answers the additional questions posed: "evian® is deeply committed to sustainability. While we cannot comment on active litigation, each year we measure carbon emissions across all life cycle stages of an evian bottle, and we continuously strive to reduce that footprint. Our bottling site runs on 100% renewable energy, and we have reduced the site's absolute energy consumption by 28% since 2008. We partner with the Livelihoods Carbon Fund, which has planted 130 million trees so far, sequestering carbon emissions from the atmosphere. evian® products are certified carbon neutral to PAS 2060 by the Carbon Trust."

Issue Date	July 2024
Topic	Lawsuit initiated by environmental group challenging evian® products's environmental claims.
Summary of Issue	In July 2024, a lawsuit was filed against Danone Waters of America, LLC (DWA) by environmental group Plastic Pollution Coalition, challenging DWA's claims that evian® products are "sustainable", "100% recyclable," pledges to make all of its plastic bottles "from 100% recycled PET by 2025," and "Made from 100% Recycled Plastic." The lawsuit also alleges that labeling the product as "natural spring water" is misleading due to the alleged presence of microplastics and BPA.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	DWA vigorously denies the allegations in the complaint and denies any liability for PPC's alleged damages on behalf of D.C. consumers. The lawsuit seeks injunctive relief only.
Impact on Stakeholder(s)	The lawsuit alleges that D.C. consumers were misled by recyclability and "natural spring water" claims on evian® product packaging.
Resolution	This matter is ongoing.
Implemented Management Practices	DWA denies the allegations in the lawsuit. Since May 2024, evian® products sold in the U.S. in plastic packaging are made from 100% recycled PET (excluding cap and label), achieving evian's® 2025 rPET goal. Further, bottled water is comprehensively regulated as a food product by the U.S. Food and Drug Administration (FDA), and evian's® bottling processes adhere to strict practices for hygiene, quality control, and food safety standards.
