Disclosure Questionnaire Statement

Disclosure Questionnaire Category: Conduct Business in Conflict Zone

Topic	Company operates in Conflict Zones.
Summary of Issue	EXO Travel had offices located in Myanmar and also organized travel in the main areas of Yangon, Bagan, Mandalay and Inle Lake. Over the years, through their Myanmar offices, the company has been able to provide employment opportunities for more than 100 people and has provided income to hundreds of companies providing services in the travel and tourism industry. The nature of the conflict in these regions included insurgency with open conflict in remote areas and localized attacks in main cities which are currently considered as being in an intrastate armed conflict.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	Less than 1% of revenue came from operations in Myanmar during FY 2022.
Impact on Stakeholders	Business activities located in conflict zones are considered high-risk as they are more likely to cause or contribute to the conflict and/or sociopolitical instability. Countries classified as conflict zones are more likely to have a weak rule-of-law or a corrupt judicial system, which could undermine the effectiveness of operational grievance mechanisms for these businesses and their suppliers. In addition, the safety of the company's workers and other potential human rights violations are at risk.
Implemented Management Practices	Since the conflict, the company has suspended their operations on the ground and the promotion of the travel experiences offered in Myanmar. All employees located in the Myanmar office have been moved to remote work for other countries within the same company and have also been provided counseling workshops focused on mental health. The company also provides private health insurance to these employees in order to supplement the governmental healthcare coverage. If their client still wants to travel to Myanmar, EXO Travel provides them with a Travel



	Advisory document that includes travel warnings, an overview of how travel insurance could be impacted, and security information. The company also has a foundation called EXO Foundation that has supported initiatives benefiting the local population specifically to the most disadvantaged in the fields of education, waste management and healthcare within this region.
