SUMMARY OF ISSUE	Company operates in neighborhoods controlled by armed ilegal groups, 10% of sales comes from services provided in these areas
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	Being a service company, the end customer is the one who requests the service in the coverage areas that the company has. Mainly PLEIA serves the metropolitan area of the city of Bogotá and the metropolitan area of the city of Medellín and for both it provides services in neighboring municipalities no more than 2 hours away from the urban area. In the aforementioned coverage areas, there are areas of armed conflict, drug sales and other illegal activities. The service It consists of going to the area and providing the service requested by the client. Approximately 10% of sales come from areas of armed conflict by criminal gangs. However, it is unknown whether or not the client has influence or relationship to the conflict.
IMPACT ON STAKEHOLDER(S)	As it is a service, the frequency is linked to the demand, normally the company enters conflict zones at least 2 or 3 times a week
RELATED INCIDENTS (YES/NO)	"A couple of years ago, the company had an experience where one of the workers was affected by conflict. Illegaly armed groups retained, threatened and intimidated the worker, extorting and requesting ransom money, using a fake service. Thanks to collaboration with police and the army the situation was controlled and PLEIA managed to remove both the vehicle and the worker from the area. Based on this experience, the company made 2 decisions:  1. Life insurance and protection for all drivers exposed to these areas. PLEIA pays 100% of the insurance and the coverage it offers.  2. Mitigation protocols for ghost services were established, where the company asks the user interested in the service to provide identification, pay in advance and send an exact location of where the pet will be picked up. On the other hand, if it is in a rural area, the company requests that the body be transferred to an urban area of the city and the service is carried out there."
