	Company is a design company that has served clientS operating in the alcohol and for-profit higher education industries. The company operates as a 'turn key' design and construction business, often delivering works from artistic concept through fabrication to completion under one contract; all services that can be sold to both controversial as well as non-controversial industries.
financial implication, # of individuals affected)	The revenue from clients in the alcohol industry is 3.3% in FY17-18. The revenue from clients in the for-profit higher education industry is 17.03% in FY21-22.
	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry.
	B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Management Practices	The company would not work within following industries: • Defense or industries that directly produce offensive firearms or Weapons • Fossil fuel extraction or refinement • Industries that include a high risk of human rights violations • Illegal products or services • Recreational drugs (even if legal in the location served) • Gambling • Payday, Short Term, or High Interest Lending • Pornography • Tobacco or nicotine products. For the other industries, the company does due diligence in screening their clients and subcontractors before working with



not used for harming people and the environment. The company does not require their clients to sign a code of conduct before working with them, but does not work with clients who do not comply with their code of conduct.
