

DISCLOSURE MATERIALS

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

ISSUE DATE	Sept-Dec 2020
TOPIC	Significant layoffs due to COVID-19
SUMMARY OF ISSUE	The bank was forced to conduct a significant reduction in force in 2020, affecting 36 staff. Impacted individuals represented all facets of the organization including executive management. The Bank made this difficult decision to reduce staff as part of a restructure that would allow the bank to continue to focus on segments of the market where it has a unique value proposition, including low-to-moderate income communities and projects focused on people and the planet. Due to the COVID-19 pandemic and general economic downturn, the bank was forced to take action immediately.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	36 employees were laid off, representing ~20% of the company's employees at that time.
IMPACT ON STAKEHOLDERS	Primary impact was loss of employment for affected employees.
IMPLEMENTED MGT PRACTICES	The company provided benefits and resources to affected employees. The bank management and the Board of Directors worked together to develop a severance program that provided impacted staff with 6 months of paid COBRA coverage, a one-time COVID-related award of \$12,000, severance pay based on individual employee tenure, and payment for all earned and unused vacation time. To provide flexibility, employees were given the option to select a lump-sum payout, bi-weekly or monthly installment payments for the COVID-related award.
RELATED INCIDENTS (YES/NO)	No other significant layoffs in last 5 years.
