

DISCLOSURE MATERIALS

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

SUMMARY OF ISSUE	As a jewelry company, Aether Diamonds operates in an industry that relies on materials that carry a potential risk of human rights infringements and conflict financing. Aether Diamonds produces its diamonds artificially, therefore not causing the negative environmental and social impact that diamond mining can often cause.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	100% of Aether Diamonds' revenue comes from the sale of diamond jewelry.
IMPACT ON STAKEHOLDERS	Companies that use diamonds in their products are historically at risk of contributing to conflict financing or human rights abuses via their mineral supply chains, particularly in the absence of supply chain traceability and management practices. Aether Diamonds' business model aims to present a solution to these issues.
IMPLEMENTED MGT PRACTICES	"100% of the company's product can be traced back through the supply chain to the original source of all raw materials. The company has a formal supplier screening policy and procedure that includes conducting regular annual visits to all manufacturing sites, requiring all vendors to complete an ESG questionnaire to ensure compliance with its standards, and having a full third-party environmental lifecycle analysis conducted for any work that relates to the production of our raw materials and finished products. There are no forced labor nor human rights violations present anywhere in the company's supply chain. The company requires all external vendors to complete updated questionnaires and allow us to visit their manufacturing facilities every year. We also mitigate the risk of forced labor and human rights violations by working with vendors that are located in Europe and North America. Any vendors outside of those regions are required to maintain third-party certifications that relate to environmental impact and ethical treatment of their employees (e.g. Responsible Jewelry Council Chain of Custody Standard & SCS007 Sustainable Diamond Standard)."
