Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Topic	Clients in Controversial Industries: For-profit Higher Education
Summary of Issue	The company is a pioneer in impact investing in Spain, currently manages the fund Creas Impacto and they are an investor and shareholders in Ironhack.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	The revenue from clients in the For-profit Higher Education industry represented 8.5% in FY 23 to 19.
Impact on Stakeholders	Companies that work with clients in controversial industries can indirectly increase the harmful impact to stakeholders by enabling business growth. Therefore, companies that work with clients in these industries should have practices in place to ensure that their impact is aimed at decreasing the negative impacts of the industry. B Lab has flagged the involvement of companies with clients in controversial industries as a material issue and new standards will be created to address possible risks related to this matter.
Implemented Management Practices	The company does not have implemented management practices as they view their investment in the controversial industry as a beneficial solution to the current gap between the demand for digitally skilled workers and the limited availability of educational resources. Ironhack reaffirms its dedication to maintaining high standards in business models, recruiting practices, and educational quality. It highlights a high employability rate at the time of investment to underscore its commitment.
