



DISCLOSURE MATERIALS

Certified B Corporations must complete a Disclosure Questionnaire to identify potentially sensitive issues related to the company (e.g. historical fines, sanctions, material litigation, or sensitive industry practices).

This component does not affect the company's score on the B Impact Assessment. If the company answers affirmatively to any items in the Disclosure Questionnaire and B Lab deems them to be material, the company must:

- 1) Be transparent about the disclosure issues identified on the company's public B Impact Report
- 2) Describe how the company has addressed this issue.
- 3) Demonstrate that management systems are in place to avoid similar issues from arising in the future.

In all cases, the Standards Advisory council reserves the right to refuse certification if the company is ultimately deemed not to uphold the spirit of the community.

In addition to the voluntary indication of sensitive issues in the Disclosure Questionnaire, companies pursuing Certification also are subject to background checks by B Lab staff. Background checks include a review of public records, news sources, and search engines for company names, brands, executives/founders, and other relevant topics.

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

IMPLEMENTED MGT PRACTICES	<p>The company complies with all of the regulations and laws related to the sale of alcohol in the jurisdictions where they operate.</p> <p>Although in Italy, and in many other countries, it is not mandatory to put on the label indications (written or in the form of a pictogram) on the risks of alcohol consumption during pregnancy, our standard labelling provides for the insertion of the pictogram. (see attached).</p> <p>In the US, however, we insert the "Government warnings" (see attached), an obligation also in Canada (limited to Yukon and Northwest Territories) and in about fifteen other smaller markets such as Israel, South America and the Far East.</p> <p>These are the Cielo e Terra standards that can be modified on specific requests from customers (normally foreign) who ask us to insert the mandatory wordings for their countries.</p>
OTHER MANAGEMENT COMMENTS	The company has an age verification request on their website 'to proceed'. The company affixes all mandatory declarations related to their products on the product label. On the company website there is a section dedicated to the conscious consumption of alcohol (https://www.cieloeterravini.com/it/bevi-responsibly).
