Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Topic	The company develops tourism activities as well as hires local suppliers in conflict zones
Summary of Issue	MEDJI Tours provides customized itineraries for travel groups for several destinations, including Israel and Palestine, territories flagged for having conflict according to the Global Conflict Tracker. The company also works with local communities and suppliers in those regions. The company was founded by two peacebuilding practitioners. After working for many years on social change programs all over the world, the founders discovered that travel was one of the most powerful and untapped resources for creating a better planet. They decided to share their unique experiences and unmatched network of contacts with their clients.
