Disclosure Materials

Sensitive issues identified through background checks may or may not be within the scope of questions in the Disclosure Questionnaire, but undergo the same review process and are subject to the same possible review by the Standards Advisory Council, including ineligibility for B Corp Certification, required remediation, or disclosure.

Topic	Tobacco Industry
Summary of Issue	The Armada Hotel, located in Ireland, permits the sale of tobacco products on its premises through a rented vending machine. The company does not receive direct income from the sales of tobacco, but since it facilitates access to these products, it is considered part of the industry.
Size/Scope of Issue (e.g. \$ financial implication, # of individuals affected)	In the last fiscal year, less than 1% of the hotel's revenues were generated through the rental of space for the tobacco vending machine.
Impact on Stakeholders	<p>Companies that work in or with controversial industries, such as tobacco, can directly or indirectly increase the industry's negative impacts on stakeholders and the communities. The tobacco-related business can increase the addiction to tobacco, a problem that can result in personal, interpersonal, vocational, financial, and/or legal risks.</p> <p>By the time of the company's next recertification, it must comply with the tobacco industry involvement thresholds in effect at that time</p>
Implemented Management Practices	<p>The Armada Hotel complies with all Irish and EU regulations regarding the sale of tobacco products. The vending machine is managed by an independent third-party provider that is responsible for complying with all relevant laws, including age-restriction controls, product-labelling requirements, and licensing obligations. The vending machine is equipped with legally required age-verification mechanisms and health warnings in accordance with Irish public health legislation.</p> <p>Tobacco products are not advertised or promoted by the hotel in any marketing communications or guest materials. Additionally, the machine is positioned discreetly and is not considered part of the guest experience offering. The hotel only receives a nominal rental fee for the space occupied by the machine.</p>



Management Comments	<p><i>The Armada Hotel’s broader strategy prioritises wellbeing, sustainability, and positive community impact. The presence of a third-party tobacco vending machine is a legacy arrangement that contributes minimally to revenue and does not reflect the direction of the business. The Armada Hotel recognises the negative health and societal impacts associated with tobacco use and seeks to minimise its involvement wherever possible.</i></p> <p><i>As part of the company's continuous improvement approach under the B Corp framework, it is reviewing this arrangement in line with future certification requirements. The company maintains a strong organisational focus on health, wellbeing, and environmental responsibility through its B Corp commitments.</i></p>
