SUMMARY OF ISSUE	Company has had lawsuits from customers and suppliers for not fulfilling contractual obligations and invoice related issues in the last 5 years.
SIZE/SCOPE OF ISSUE (e.g. \$ financial implication, # of individuals affected)	The company has had 16 lawsuits with the total payments / settlement amounts not exceeding 1% of the company's revenue in the respective fiscal year.
RESOLUTION	Of the lawsuits mentioned above, 13 were settled and for 3 lawsuits the court's verdict was against the company (amounting to 0.01-0.23% of revenue in the respective fiscal year).
IMPLEMENTED MGT PRACTICES	The company subscribes to the Code of Conduct of the direct selling association of which NWG is a partner since 2007. The company has updated its internal procedures and established an articulated process of authorizing contracts and invoices.
	Periodically the company undergoes a due diligence process with an external legal partner in order to verify NWG's compliance to legal requirements of the sector in which they operate. For improving customer communications and expectations, the company's sales personnel are accompanied by a product specialist to explain the products and offer to the customers correctly. Further, the company has a customer care department for all customer requests and complaints.
OTHER MANAGEMENT COMMENTS	In the second part of the 2021 the company is planning to work on a risk assessment per the Italian legislative decree - dlgs 231/01 pertaining to responsibilities of entities.
